Past Winners and Repeat Applicants

To ensure equitable access to funding, past recipients of a Stay Outdoors grant are not eligible to apply again for a period of three (3) calendar years following the year in which funding was received.

Recipients who received a grant in 2022 or earlier are eligible to reapply in 2026, while those who received funding in 2023 or later are not eligible.

Required Documents

1. A letter of recommendation from at least one authorized Yamaha dealer
2. Documentation verifying nonprofit or tax-exempt status
3. An itemized project budget, including purchase orders, estimates, and/or quotes
4. A project scope of work and timeline
